TERMS AND CONDITIONS

CONFIRMATION OF EVENT

Your reservation will be officially confirmed once we receive a deposit amounting to fifty percent (50%) of the Total Charges, unless alternate arrangements have been agreed upon with the venue, as outlined in the signed Event Agreement. Please note that the deposit can be made using a credit card, direct deposit or cash.

The deposit will be applied as a credit towards your final bill. In the event that the venue does not receive your deposit within a seven (7) day period, we reserve the right to release the booking. We will make every effort to contact you before releasing the booking date. Your final invoice will be sent to the contact information you have provided.

FINAL PAYMENT AND GST

The final payment of the account (less the deposit) is due twenty-four (24) hours from the date of the invoice and no later than seventy-two (72) hours prior to the event date.

All prices are inclusive of GST charges.

CANCELLATION OF THE EVENT

The entire event may be cancelled by notice in writing to Swing City Golf. Where notice of cancellation is given up to four (4) weeks prior to the date of the event a full refund of your deposit will be given. Should the booking be cancelled less than four (4) weeks prior to the event, the deposit is forfeited.

RESCHEDULING OF EVENT

The event may be rescheduled by notice in writing to Swing City Golf. Where notice is given up to two (2) weeks prior to the event, the deposit will be rolled over to the new event date. Should the booking be rescheduled less than two (2) weeks prior to the event, 50% of the deposit will be rolled over to the new event and 50% of the deposit will be forfeited.

EVENT ORDER

To ensure your requirements are met, it is necessary to confirm your function schedule and catering requirements seven (7) working days prior to the event. You are required to confirm the final count of Event Guests with our Event Sales Department at least seven (7) days before the Event Date. Any increase in the number of Event Guests beyond what is included in the originally booked online package may result in additional charges. If additional guests attend the Event without prior notification, Swing City will determine the final count based on the originally booked package, and extra fees may be applicable. We will do our best to accommodate additional guests based on availability.

Please note that Swing City Golf reserves the right to assign or substitute the Client's originally booked space with a comparable space in order to accommodate the Client and all other guests using our facilities.

Each bay accommodates a maximum of 6 persons. When you book your event, we will divide the number of attendees by 6 to determine the number of bays allocated to your event. Swing City retains the authority to adjust the event order as necessary to ensure the venue operates smoothly.

INCREASE TO CHARGES

Swing City Golf reserves the right to adjust the Total Charges at its discretion under the following circumstances:

1. Between the date when the Total Charges are initially outlined in the Event Agreement provided to the Client and the Event Date, if any of the following occur:
 - a. There is a significant increase in the cost of labor or goods, including but not limited to unexpected rises in the price of fresh produce when a suitable alternative ingredient is unavailable.
 - b. There is an introduction of or an increase in any Federal, State, or local government taxes, rates, or charges, such as GST or similar taxes.

Swing City Golf will promptly inform the Client of any adjustments to the Total Charges once they become known to us. Any increase, except as detailed here, will be limited to the amount that, in Swing City's reasonable judgment, covers the additional direct costs incurred.

FOOD & BEVERAGE

It is the policy of the Swing City Golf that no food, beverage, or alcohol other than that supplied by the Venue may be brought into the venue or venue grounds, for consumption under any circumstances. Catering arrangements will proceed, as organised irrespective of weather. If mutually agreeable, the timing of service may vary. Event food and beverage cannot be packaged "to-go" and must be consumed on-site.

Swing City retains the authority to verify the identification of any individual. In accordance with liquor licensing regulations, Swing City may, without limitation:

- I. Request valid legal identification from anyone whose age is in question.
- II. Exercise its sole and absolute discretion to deny the service of alcoholic beverages to individuals who are underage or unable to produce proper identification upon request.
- III. Refuse to serve alcoholic beverages to individuals who, in the sole and absolute judgment of Swing City, appear to be intoxicated or under the influence of substances affecting their mental state.

In the event that minors attending the Event are observed consuming alcoholic beverages on the premises, Swing City reserves the sole and absolute discretion to promptly terminate the Event without any further obligations to the Client or any Event guests.

PERSONAL PROPERTY

The Client takes on all the risks and responsibilities associated with any personal property and/or equipment brought onto the premises for the Event. This property may include items that could be damaged, lost, stolen, or inadvertently left on the premises before, during, or after the Event. The Client agrees not to hold Swing City Golf accountable or liable for any such losses, thefts, or damages. Swing City will not receive deliveries for the storage of Event-related items unless the Client has obtained prior written approval from the Event Sales Department at least seven (7) days prior to the Event Date. All items shipped are done so at the Client's own risk.

ENTERTAINMENT AND DECORATIONS

Any decorations, promotional materials, and externally contracted entertainment, including signs and banners provided by the Client, must be coordinated with and granted approval by

the Swing City Event Sales Department no less than seven (7) days in advance of the Event Date. Swing City retains the right to impose limitations and/or restrictions on any banners or signage that display company logos.

Kindly note: helium balloons are no longer permitted in our venue due to the risk of entanglement in our driving range nets.

A time limit will be imposed on bump in and bump out.

NOISE RESTRICTIONS

The Client acknowledges and agrees that the venue is subject to legally mandated noise restrictions. Consequently, the Client and/or any external entertainers hired by the Client for the Event must:

- Collaborate with the Swing City' Operations Manager and/or Event supervisor before setting up to receive guidance on the compulsory noise limitations.
- Promptly adhere to Swing City' directives concerning noise levels during any performance.
- Failure to comply with these instructions regarding noise levels may lead to the termination of the performance by any means deemed appropriate by Swing City, without any available recourse for the Client in this regard. The Client is responsible for ensuring that any external entertainers it has contracted conduct their activities in accordance with these terms and conditions at all times.

SMOKING

New South Wales laws prohibit smoking in designated areas. The Client commits to ensuring that both themselves, their guests, and any contractors (if applicable) adhere to any instructions provided by Swing City to cease smoking or restrict smoking to designated areas.

SAFETY

The Client is responsible for ensuring that all Event guests adhere to the Safety Terms and Conditions provided herein. Swing City will not assume liability in cases where injuries occur due to noncompliance with these conditions or when children under the age of 16 are not adequately supervised by an individual aged 18 or older.

Furthermore, the Client may not enlist any contractor to carry out activities on its behalf within the premises without obtaining prior written approval from Swing City. It is the Client's responsibility to guarantee that each of its contractors complies with Swing City' workplace health and safety regulations and contractor control policies, which will be communicated to the Client and must meet Swing City' insurance requirements.

INSURANCE AND INDEMNITY

The Client and Swing City are each responsible for securing and keeping active liability insurance through a financially stable and reputable insurer to fulfill their obligations as outlined in this Event Agreement. Upon the signing of this Event Agreement and prior to the initiation of any services, Swing City retains the authority to request that the Client provides a certificate of public/product liability insurance from said insurers. This certificate should provide coverage of a minimum of Twenty Million Dollars (\$20,000,000) per incident and in total. Swing City and the Client each commit to indemnify, defend, and hold harmless the other party, as well as their respective affiliates, agents, representatives, directors, officers, and employees, from any and all claims (including, but not limited to, third-party claims), lawsuits, fees, losses, liabilities, damages, judgments, costs, and expenses (collectively referred to as "Claims"). These Claims include reasonable attorney fees incurred as a result of such Claims, stemming from the actions of the indemnifying party in accordance with this Event Agreement. This includes, but is not limited to:

- a) Gross negligence or willful misconduct by the indemnifying party in the execution or nonexecution of this Event Agreement.
- b) Violation of any representation, warranty, or other obligation under this Event Agreement.
- c) Any personal injury (including death) or property damage arising from the acts or omissions of the indemnifying party, its employees, invitees, or guests.

PRIVACY

Any personal information gathered will be managed in accordance with the Mulpha Privacy Policy.

DAMAGE

Loss or damage to any part of the Venue or its equipment will be the financial responsibility of the organizer. Nothing is to be nailed, screwed, stapled, or adhered to any wall, door, window or other parts of the building.

DELIVERIES

The event coordinator must be notified in advance of any deliveries to the Venue. All items should be marked for the attention of "Events Department" with the function name, date and number of items being delivered. The Venue will not accept responsibility for items left on the premises more than 48 hours at the conclusion of the function without prior arrangement.

ACCEPTANCE OF THESE TERMS AND CONDITIONS

For the purposes of these Terms and Conditions, the term "Event Agreement" as used herein refers to the Swing City Golf Event Agreement in conjunction with these stipulated terms and conditions. Safety is of paramount importance to us. By participating in an event at Swing City, all participants agree to adhere to the following safety regulations, in addition to verbal and posted instructions provided during the event:

All players must consistently hit from the mat, with no running starts or rough play allowed.

Only the individual hitting a ball should stand beyond the red line. All other players should remain behind the red line at all times. Players bear the responsibility for ensuring the safety of those around them and should always assess their surroundings before swinging a club.

Always aim for the targets. It is strictly prohibited to target the ball picker or hit golf balls over the boundary netting, and players are liable for any damages or injuries caused by such actions.

Players are required to stay behind the yellow line at all times, with extra caution exercised when playing from the upper bays.

Guests under the age of 16 must be supervised by an individual aged 18 or older when playing.

Throwing golf balls is not permitted, and only one golf ball should be dispensed at a time.

Swing City does not assume responsibility for lost or stolen items.

Upon the completion of payment, the party involved hereby acknowledges and agrees to abide by the terms and conditions stipulated in this contract. It is expressly understood that the confirmation of the specified event is contingent upon the receipt of a deposit.
